

**NEBRASKA PAINT HORSE CLUB
2008 OPEN FUTURITY
ELIGIBILITY**

Any horse registered with the American Paint Horse Association either regular *or* breeding stock registry. Horses already registered **MUST** send a photocopy of their registration papers with their payment. For weanlings not yet registered a photocopy of the registration application **MUST** be included with the payment.

ORIGINAL PAPERS FOR EACH ENTRY MUST BE IN HAND AND MAY BE CHECKED BEFORE ENTERING ARENA FOR CLASS JUDGING. NOVICE/AMATUER AND OR YOUTH CARDS MUST BE SHOWN FOR THE NON-PRO CLASS AT TIME OF ENTRY. NO EXCEPTIONS.

The number of entries received as of August 1 will determine the division between early and late filly and colt weanlings. If a division has less then six (6) entries, the divisions will be combined and money will be paid according to the TOTAL number of paid up entries.

FUTURITY ENTRY AND PAYMENT SCHEDULE

Halter.....	\$50.00 due on or before August 1
Performance.....	\$100.00 due on or before August 1
Late Fees accepted.....	\$50.00 late fee after August 1 – up to two (2) hours prior to start of show
Stall Fees.....	\$ 25.00 per stall/per day/per horse

Each horse is subject to a \$10 office charge; make checks payable to NPHC.

The **CLASS, HORSE, and OWNER MUST** be named with the payment.

All registered owners of all horses entered in Open Futurity are required to be a Nebraska Paint Horse Club member in good standing. Enclose a **SEPARATE** membership check (**\$40.00**) payable to NPHC with entry. Entries in Open Futurity **ARE NOT REQUIRED** to exhibit in the corresponding APHA class, but are encourage to do so.

REFUNDS

No refunds will be paid to nominators not paid up by August 1. The **ONLY** refund allowed will be the notification to the futurity committee *in writing* from a licensed veterinarian of the death of the horse by show date.

PAYBACK

Prize money is based on moneys collected for each individual class and the number of entries paid up. Prize money will be withheld pending any drug testing results. Money will be distributed as follows:

Halter classes will be shown under 2 judges and Performance classes will be shown under 4 judges with two (2) go-rounds. In the event of a tie all tie money will be added together and divided equally among tied entries.

SHOWING SCHEDULE

All halter classes will be judged in one go-round. Performance classes (Lunge line, and Western Pleasure classes) will be judged in two (2) go-rounds. The same exhibitor must show in both go-rounds to be eligible for winnings.

DRUG TESTING

All horses shown in the futurity shall submit to testing at random for the presence of prohibited medications. The prize money in that division will be withheld pending the receipt of the results of any drug tests. All APHA rules and regulations relating to prohibited medications and alteration of tails will be applicable.

MISCELLANEOUS

- (1) Absolutely No Substitutions will be allowed.
- (2) Stallions gelded before the futurity date may be switched from the yearling stallion class to the yearling gelding class upon notification to the futurity committee.
- (3) An entry may change ownership and retain eligibility under the new owner provided all fees and memberships are paid and the futurity committee is notified.
- (4) APHA rules will govern all appropriate classes.
